### **Toms story**



One Christmas, I read an article about loneliness and realised how many people throughout the UK are in desperate need of companionship. I did what every thirty-something does when in need of some answers, I fired up my laptop, and looked to Google.

I came across SCCCC and arranged to meet with the Volunteer Coordinator to find out how I could help. We talked for a while getting to know each other, and a few days later, my formal induction was arranged.

Over the course of the next year or so, I visited a lady once a week for roughly an hour each visit. Sadly, she became quite ill, so we agreed to stop my visits. I was then matched with an amazing character whose first words to me were, "I'm 94 and I'm going for the 100 so I can get my letter from her Majesty" - we get on like a house on fire!

As a volunteer for SCCCC, I feel valued. The staff at the charity continuously provide support for me as and when I may need it. I am sent birthday and Christmas cards, and am always updated with what's going on in the SCCCC's calendar. I also have an allocated Supervisor I can contact any time to discuss anything relating to my visits.

I continue to enjoy my time volunteering, and it warms my cockles knowing that the very small amount of time I give once a week makes a real difference to somebody's quality of life.



#### As we enter into the new 'roaring twenties', SCCCC and our work with lonely and isolated older people will continue to grow and develop.

It's hard to believe that the charity has now existed in SIX decades and it's almost sad that the services we provide are STILL needed after all this time. But they are, and as always, we need YOUR help to ensure we may continue to care for older people in the Sheffield area.

### STAFF PROFILE... Sarah Kelly

#### What does your role involve?

Facilitating discharges from hospital to home.

This includes providing transport, fitting equipment, shopping, moving furniture to make space for hospital beds, signposting to other services and taking referrals over the phone. The aim is to provide a practical, supportive and friendly service to those who are over 65 and vulnerable.

#### What does a typical day involve?

Every day is different and varied. A typical day starts with coordinating and prioritising jobs for the day. Once I get my job list, I phone all the relevant people informing them of my visit, plan my route and get all the equipment and supplies I need.

Then on the road I go. When each job is finished, I liaise with the referrer (this could be Occupational Therapists, physiotherapists, Nurses or Social workers) to inform them on how it all went and any other important information they may need to know.

#### What is the best aspect of your job?

Being part of the hospital to home team I meet people at one of the most stressful times of their lives following a stay in hospital or a period of ill-health. Being able to have the time to support someone back home by helping them with the practicalities but most importantly listening, showing kindness and friendship, is a privilege. Then seeing how their anxieties turn to smiles and confidence means the world to me. I also really enjoy hearing about people's life stories and experiences. Watching people light up reminiscing allows me to see that person as an individual not as a patient or customer. And my favorite is getting a hug at the end.

#### And the worst?

Not so much the worse but the hardest part is seeing the loneliness and social isolation behind closed doors. I see how this contributes to declining ill-health and well-being. On a positive note I feel proud to be part of the work SCCCC are doing to help combat this.
