Spectacular Queen's Jubilee

170 older people from across the city were invited to a very special Queen's Platinum Jubilee celebration in June. Held at the historical Crowne Plaza Royal Victoria Hotel, guests were treated to a right royal day out with afternoon tea, live entertainment and a goodie bag.

Organised by SCCCC and Kathy Markwick, a Freelance Community Consultant, the day was an opportunity for older people to get dressed up, enjoy a light lunch, dance and chat and celebrate the Queen's 70-year reign.

The Queen's representative Deputy Lieutenant, Kim Streets, spoke about the work of SCCCC before raising a glass to Her Majesty and guests stood for the National Anthem.

The room was a sea of red, white and blue, glitter and sparkle with many guests wearing tiaras and party hats. Plates of sandwiches, scones, cream and jam were enjoyed with a proper cup of tea.

Musical entertainers Joseph O'Brien and Oliver Harris, got everyone up and dancing with songs from a bygone era. Guests were accompanied on the dance floor by amazing volunteers, from SCCCC and Gripple Foundation. City Taxis provided free transport for our most vulnerable guests and SCCCC staff were on hand to assist, chatting to guests, and making them feel extra special.

102 year old Ivy Richards told us what made the day so special – Ivy said 'I lost my son 6 weeks ago and it has made me feel very sad to outlive him. I felt quite low this morning until now – this has been wonderful and it has made me feel so happy – I am 102 and today I feel 22 all over again. Please thank all the people who have made this event possible as I have had such a lovely time."

Our Queen's Platinum Jubilee celebration event was a roaring success, with wonderful feedback from the special guests who attended, many of whom had not left their homes for years due to the pandemic. Volunteer profile: Rob Southern – Good Neighbour Scheme volunteer

Why did you choose to volunteer at SCCCC?

I chose to volunteer as I'm studying to be a therapist and I was looking for ways to practice the skills I was learning and also to help someone who needs some support was a bonus for that.

Who do you visit?

I visit John, an elderly man, who lives on his own and lost his wife recently and has lots of difficulties both physically and mentally.

How have you found it so far?

It's been rewarding, but also challenging. With John being an older person in his 80s, a lot of the things I'm learning about in therapy come up when visiting him. John speaks a lot about death and being ready to die, which has been valuable learning and also valuable for John to actually be able to talk about that.

What is it that you get out of volunteering?

Mainly I get a sense that I've made a difference. John is very explicit about how much he enjoys the visits. Also, with that, because I see him for only an hour each week, it's amazing how so little from me makes such a difference, with just an hour each week there comes a feeling like more could be done.

How important do you

feel it is that older people are supported?

Hugely, we're all going to be there one day, and we might need that kind of support, so I think it's very important.

Would you recommend volunteering with SCCCC?

Yeah, everyone I've dealt with has been lovely, it has been very clear as to what to expect, I've not been surprised by anything in the role, and so it has been a nice experience overall.

Could you offer a helping hand? Volunteer for SCCCC

Each day the Hospital to Home team drive miles around Sheffield delivering equipment and helping to support older people whilst in hospital, on discharge and beyond. We are always looking for volunteers to spend time with the team to assist in the following tasks:

- Collection of personal belongings for patients whilst in hospital.
- Delivery of equipment such as mobility aids, temporary key safes.
- An emergency food shop.
- The moving of furniture to make way for a hospital bed in a patient's home.
- Feeding pets.

You would always be accompanied by a member of staff and the time commitment can be for a full day, morning or afternoon.
